## Details and Terms of the Promotion

### Scope

1. The Promotion applies to the Polish Localization application and the complementary Polish Language (Poland) application – available exclusively for Business Central Online.
2. The promotional price applies to each full user under the Dynamics 365 Business Central Essentials and Premium license plans.
3. The promotional price is valid for 12 months under an annual subscription commitment.

### Duration
